6. Any records in the E-Gov Travel Service (ETS/ETS2) system mentioning or referring to any Trump Property.
7. Any records in the SmartPay Purchase Charge Card Program system or records mentioning or referring to any Trump business.
8. Any and all records reflecting charges to a Government Travel Charge Card or other governmental charge card for expenditures at Trump businesses.

9. Any and all other records reflecting expenditures to any Trump businesses.
